I. Call to Order

II. Roll Call

III. Adoption of Agenda (Discussion/Action) Motion to approve the agenda for June 21, 2022 by Mr. Weisz; second by Mr. Hill. Two ayes to approve (Weisz, Hill).

IV. Public Comments There were none.

VII. Review of Newark Unified School District's Internal Controls as related to the Audit Committee Charter Matrix (Discussion)

- Audit Committee Charter Matrix Section #9:
 - The district is to make a rough list of controls that have been requested by the auditor for the current audit.
- Audit Committee Charter Matrix Section #3:
 - Will get input from committee members and district staff to provide feedback on recommended changes/updates to the charter.
- Audit Committee Charter Matrix Sections #6, 7, and 12:
 - It was shared that the County provides oversight and guidelines for auditors, ie: individual partner cannot work more than three (3) years on district audit.
 - Questioned if the committee wants to put together a "score card" to evaluate Christy White (see #12 in Charter).
 - If going out to bid for a new auditor, the committee would want to assess management time and costs.
- Audit Committee Charter Matrix Additional Responsibilities:
 - Discussed the possibility of adding "scope" of committee responsibilities (what they look at and what they do not). Scope of the committee is to assess the process, not

to stop problems.

- Looked at item g. reporting on status of previous audits as something to discuss.
