Thank you for the information. Just a quick observation if I may.

Without a Master Facilities Plan, it seems that we chose our past, current, and future projects based on Facilities Needs Assessment rather than looking at the long-term vision of the District in the next 10-15 years. Granted Facilities Needs Assessment is an important component, but it is not the whole picture when looking at long-term. Review Demographic Projection, Financial & Funding Source Analysis, e.g. Alternative Funding Source from Joint Use, AND Confirm Education Standards, e.g. Program Goals, Spaces & Equipments Needs, are 3 other components that are just as important. The Master Facilities Plan is to define the long-range goals for facilities planning that support the educational goals of the District. Without one, I fear that our effort to school facility improvements will fall short of this long-range goals.
